Junk Control and Animal Control Draft Ordinances Out for Public Comment

In response to citizens' passage of the **Limited Self– Government Act** in June of 2006, the County has released the first two nuisance ordinances to address the problems of **junk** and **animals** that present a public nuisance in the unincorporated areas of the County.

The ordinances are available for citizens to comment on for the next few weeks. Commissioners held a public input meeting on March 12th—the response to the ordinances was overwhelmingly positive.

There will be another opportunity for citizens in Commissioner Nodine's district to provide their input as well on the two ordinances. It will be held Tuesday, April 3 at 6:00 Pm at the Semmes Community Center–10141 Moffett Rd.

After the public comment period has ended, the Commission will release a final draft of the two ordinances for public notice. The notice period will last 30 days, after which the Commission will vote on the ordinances at the following Commission meeting.
