## **General Information**

When we receive the above "application for appointment as notary public", it will be processed. If approved, we will mail a "letter of appointment" from the Judge of Probate. When you receive this, you will have 40 days from the date on your "letter of appointment" to obtain and record a "notary bond". The notary bond may be purchased from certain insurance, bonding, or surety companies. Ask if the company issues notary bonds and show them your "letter of appointment" so they can fill in the correct dates on the bond. Notary bonds are made out in the amount of \$10,000. Bring or send your notary bond and recording fee in the amount of \$14.00 to the Court's Recording Division. Upon receipt and recording of your notary bond, you will be mailed a "notary commission". You are not to perform any notary act until you have received your final "notary commission". Notary seals may be purchased from office supply stores, etc.
